6. PRESENTATIONS

[FT\Info] A. First Transit General Manager Robb Howell – Employee Recognition and Operations Report.

Mr. Howell recognized the November 2009 Operator-of-the-Month Laddavanh Guss. Ms. Guss has been a bus operator since 2004 and currently operates bus service on the Dale City OmniLink route.

Mr. Howell reported 14 commendations (directed to 12 different bus operators). He went on to report the accident frequency rate during the month of December is 1.35 per 100,000 miles. He also reported the complaint rate on the OmniRide service for December is 7.04 per 10,000 passengers compared to 8.42 for the prior month and the year-to-date is 6.95 compared to 7.59 for the same period last year. The complaint rate on the OmniLink service increased from 3.9 in November to 5.8 in December. Mr. Howell attributed the complaint rate increase to the inclement weather. The year-to-date is 4.64 compared to 5.13 for the same period last year.

With regard to the bus operator shortage, Mr. Howell reported five bus operators are scheduled to graduate on Monday, and training efforts continue with a new class commencing shortly. He explained First Transit typically projects bus operator turnover rates and training classes are sized accordingly. However, an unexpectedly high number of terminations and illnesses resulted in a total of seven missed trips the morning of January 5.

10. VIRGINIA RAILWAY EXPRESS (VRE)

[VRE\Info] A. Operations Board Meeting Agenda and Minutes of  
December 18, 2009.

[VRE\Info] B. Chief Executive Officer's Report (12-09).

Mr. Zehner reported VRE experienced its highest ridership (18,629) yesterday, and the day prior was the second highest. Ridership is up 2.2% for the year and train delays for the calendar year have decreased by 37%. On-time performance in calendar year 2009 was 90% on both lines (Fredericksburg line at 89% and Manassas line at 91%). The majority of the VRE trains are carrying "standees."

Mr. Zehner noted the first five of ten new railcars will ship tomorrow out of Chicago followed by the delivery of the second five new railcars next week, bringing the total number of railcars to 71. The new railcars will be placed into service, replacing over-aged



Commissioner Kelly moved, with a second by Commissioner Crisp, to authorize and approve the proposed actions as presented. There was no discussion on the motion. (KELLY\CRISP, UNANIMOUS)

11. CHAIRMAN'S TIME

Chairman May had nothing to report at this time and wished everyone a Happy New Year.

12. EXECUTIVE DIRECTOR'S TIME

[PRTC\Info] A. Executive Director's Report.

Mr. Harf reported an "on-line forum" is scheduled for Tuesday, February 9, 12:00 p.m., and a series of "public hearings" are scheduled for Wednesday, February 10, 4:00 p.m. and 7:00 p.m., at the PRTC Transit Center and Thursday, February 11, 4:00 p.m. and 7:00 p.m., at the Manassas City Hall, to invite public reaction to the proposed FY 2011 budget and fare increase. Mr. Harf expressed appreciation to Vice Chairman Way for allowing PRTC the use of the Manassas City Hall. He noted that staff will return to the Commission at its March meeting with the outcome of the public review process which could result in an adjustment to the FY 2011 budget.

Mr. Harf went on to report that PRTC has locked in diesel fuel (25%) for FY 2011 at a cost of about \$2.35/gallon. Staff will continue to research opportunities to lock in more fuel.

Moving to another subject, Mr. Harf noted the Virginia Department of Rail and Public Transportation (DRPT) recently completed a financial audit of PRTC. The consultant's work is complete, and the results have been transmitted to DRPT. PRTC will be afforded an opportunity to react to the results once they have been formally transmitted. There were no findings by the consultants that rose to the level of any material concern.

Mr. Harf noted that commencing February 3, the Federal Transit Administration (FTA) will conduct a week-long financial management audit. Results of the audit will be presented to the Commission upon completion.

Referring to the bus operator shortage, Mr. Harf commended both PRTC and First Transit staff for above-and-beyond efforts to mitigate the impacts on customers and to ensure PRTC does not experience a recurrence of that magnitude. He noted that PRTC operated all of the scheduled bus service the next day. Staff met with customers Wednesday morning to express PRTC's apology/regrets and to invite customers to voice any complaints. He went on to note that customers were understanding, pleased about PRTC's quick recovery, and appreciative that the Commission cares about the quality of the bus service.

Continuing, Mr. Harf reported the 2.1% motor fuels tax is now being levied on "distributors." He went on to explain that both PRTC and NVTC expressed concerns about the Department of Taxation's "exemption" of certain costs from what's taxable (e.g., transportation) and has sought, without success, to elicit a reaction from the Taxation





13. OTHER BUSINESS/COMMISSIONERS' TIME

Delegate Lingamfelter commented that the Appropriations Committee staff announced that two large transit payments will be paid in full in the February/March time frame. He explained there is already authorized funding available and approximately \$435 million will become available. He recommended the Commission meet with the new Secretary of Transportation on this issue and volunteered the use of his office.

Mr. Harf noted that he participated in a pair of meetings with the aim to provide Governor-elect McDonnell's transition team members to provide an enhanced understanding of public transit issues. The first meeting was with former Congressman Tom Davis, and the second meeting was with former Virginia Secretary of Transportation Whitt Clement and members of the Rail and Public Transit Task Force.

Commissioner Caddigan noted that Ms. Cynthia Martinez has requested an update about PRTC bus service operating to the Fortuna Shopping Center located at Rt. 234. Ms. Martinez requested the bus service at a PRTC meeting several years ago and understood the response at the time to be that the bus service would commence in 2010. Commissioner Caddigan asked the Executive Director to respond to Ms. Martinez.

14. ADJOURNMENT

There being no further business to come before the Commission, Chairman May adjourned the meeting at 7:35 p.m.
