
RE: RESOLUTION AUTHORIZING THE POTOMAC AND RAPPAHANNOCK TRANSPORTATION COMMISSION (PRTC) TO USE \$301,433 OF THE CITY OF MANASSAS GAS TAX FUNDS

WHEREAS, the Council of the City of Manassas has determined that it is appropriate to pay for PRTC administration, PRTC marketing, Local Capital Match, parking lot leases and debt service on the Virginia Railway Express parking deck with its gas tax funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Manassas, Virginia, meeting in regular session this 28<sup>th</sup> day of April, 2008, that PRTC is authorized to appropriate \$301,433 from the City's gas tax funds for:
